2019 ANNUAL MEETING MINUTES

November 10, 2019

CONGREGATION PRESENT: At least 75 members (quorum) are needed for voting purposes. There were 80 members present, surpassing the quorum requirement.

- **CALL TO ORDER:** Council President Jeff Hook called the meeting to order at 9:38 am and Pastor John led the congregation in an opening prayer.
 - 1. Diane Bartz made a motion to approve the Congregational Annual meeting minutes from November 11, 2018, second by Katie Zelle. Motion passed.
 - 2. Jeff Hook thanked the outgoing Council members for their service.

ELECTIONS: Jeff Hook reviewed the ballot and accepted nominations from the floor for the following positions:

- 1. Church Council: 6 open positions, 3 found; the constitution calls for "not more than 12"; there were 11 voting members in 2019. The floor was open for nominations from council; second call for nominations; third call from the floor for nominations; motion to close. Betsy Baguhn made a motion to close the nominations, second by Warren Wilson; motion passed.
- 2. Audit, Endowment and Personnel: Call for nominations from the floor; second call; third call; motion to close the nominations; Irv Steinhauer made a motion to close the nominations, second by Kate Hook; motion passed.
- 3. Nominating Committee: 6 for a 1-year term. Call for nominations from the floor.
 - a. Kristin Willcutt nominated Diane Twiton.
 - b. Katie Zelle nominated Kristin Wilcutt. (after discussion following the meeting the nomination was declined.
 - c. Third call for nominations; motion to close the nominations; Char Smith made a motion to close the nominations, second by Sandy Glaeve, motion passed.
- 4. Synod Assembly: January 18 Town Hall; important year ahead; Sara Larson nominates Diane Bartz; second call from the floor; third call from the floor; motion to close made by Betty Drape, second by Warren Wilson; motion passed.
- 5. Synod Assembly Youth: Per Diane Bartz, we are allowed 2. Call for nominations from the floor; second call for nominations; third call for nominations; the Council will select the youth.

PASTOR'S REPORT (in the annual report on page 9)

- Special mention was made of the successes of the past year: Mission trips; 25 attended last year, 36 for next year; Benevolence (Saba); Veteran's Outreach; Wednesday's with Luther; Internship Ministry; Women's Ministry; Worship(music).
- What's next? Unchartered territory and a wonderful opportunity for us.
- Spanish Immersion Program in Puerto Rico, 1/24/2020 2/1/2020; registration fee is \$600

TREASURE REPORTS (in the annual report on pages 19-25) 2020 change in that the Council requested the Budget and Finance Committee to build in the 2020 budget costs to accommodate an intern for the 2020-2021 intern cycle; Salary of \$8,000 and Housing of \$6,667

BUDGET AND FINANCE REPORT (in the annual report on page 17)

Review of the fund balance history for 2016-2019; big spike in 2017 due to tax law changes. Back down in 2018, as there was lower giving in December 2018, plus higher utilities and dishwasher repairs. Down in 2019 but looking like we will break even. The mortgage balance is down after the extra \$10,000 payment was made to bring the amount of cash down. The Designated Fund is down after funds were used for the intern. Regarding the General Fund, Steve Hall is looking for some large gifts again at year end. Running the intern through the General Fund should roughly break even.

BUILDING AND MAINTENANCE (in the annual report on page 13) Expenses were up with a lot of repairs and income was down for the year. Thank you to Diane Bartz for the excellent work in this area.

2020 BUDGET Next year, budgeting a 9% increase in giving. Consensus is there is a willingness for people to give to support the intern. Asking that the congregation increase giving to make the budget work. Drivers for the 2020 budget are personnel/intern, congregational life (Wednesday's with Luther), Building and Office (snow removal), utilities. Building and maintenance- income of \$8,000, expenses of \$16,000.

- **CLOSING BY PASTOR JOHN WITH THE LORD'S PRAYER** Word of thanks to Jeff Hook for all his work as president the past two years.
- MOTION TO ADJOURN Motion to adjourn the meeting made by Diane Bartz, second by Steve Steinl, motion passed at 10:38 am.

LEADERSHIP REPORTS

Pastor John Twiton

In the presence of God and of Christ Jesus, who is to judge the living and the dead, and in view of his appearing and his kingdom, I solemnly urge you: ²proclaim the message; be persistent whether the time is favorable or unfavorable; convince, rebuke, and encourage, with the utmost patience in teaching. 2 Timothy 4:1-2

A couple years ago at the annual meeting, after discussing many of the changes and challenges of the church in this century, I concluded with the image of 'sailing into uncharted territory'. Looking back, it seems that was a much simpler time than today. None of us could have imagined the challenges of this past year. There truly is no map for doing ministry this year. But the call to be about ministry has never had conditions on it. Paul wrote to his friend Timothy: "Proclaim the message, be persistent whether the time is favorable or unfavorable". So we seek to continue to proclaim that Good News of God's love in Jesus Christ in the midst of these days as well.

I've heard many people say that they are tired of living this way, and I am too. When I placed the signs on the door on March 17th which said that our building was closed to public access, I couldn't imagine that they would still be in place in November. Like so many others, I long for the day when we can gather to worship, sing, share hugs and fill the fellowship hall for meals and gatherings, but love of our neighbor, and concern for the health of others makes it wise and responsible to avoid these gatherings. I wish I could say that an end is in sight, but the current conditions in our county, our village, and the surrounding area continue to worsen. (As I write this the Department of Health is reporting record numbers of people hospitalized in Dane County, more than double what they were in April. The number of infections in the Village of Mt. Horeb has jumped from 82 in September 17th to 145 today (10/26).

Five hundred years ago Martin Luther had to face circumstances not too unlike ours. The plague that raced through Europe in the 1500's may have killed one-third of the population, war and civil unrest racked the continent, and a new technology (the printing press) made it possible to reach people in a new way. The circumstances were not favorable, the work of the church was difficult, but Martin persevered in preaching the Good News and God saw the church through to a new day. Luther was realistic about doing what was best, he wrote to his friend John Hess: *"I shall ask God mercifully to protect us. Then I shall fumigate, help purify the air, administer medicine and take it. I shall avoid places and persons where my presence is not needed in order not to become contaminated and thus perchance inflict and pollute others and so cause their death as a result of my negligence."*

The Good News of God's love in Christ will continue to be shared. We will, like Luther, make the best use possible of current innovations in communication and technology, and we will continue to exercise caution in our interactions to avoid causing the spread of illness due to negligence. Yes, we'd all like this to be over right now, and I'm confident that by God's grace, we will persevere. In the meantime, we will need God's gifts of creativity, compassion, and faithfulness. We count on the God-given wisdom of researchers and the gifts of healing shared through those who serve in health care to help us find new ways to confront disease. But most of all we live in the presence of our God who promises to be with us always, not only when we gather, but wherever we call on God's Spirit.

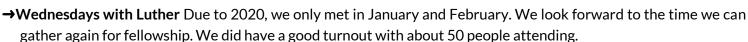

Youth Director Update - Children & Youth Ministry

2020 has been quite a year. In March, we had to rethink how we provide our educational opportunities, when everything began to close down. Sunday School, Confirmation, VBS/Day Camp 2 GO and FUSE all went to using Zoom (online) for their classes since March, and continue to do so. Throughout the pandemic, we continue to be creative on how we can keep everyone connected, in a time when we are not to be together.

- → Sunday School classes for ages 3 years old through 8th grade. High school youth are helping online. Students join on Sundays for our lesson time or may work with their families at home, using the emailed materials. Lessons include a fun story, craft with materials at home, and some games/activities.
- →Confirmation meets on Wednesday evenings for 7th and 8th graders. This fall we have 21 -7th graders, 18 -8th graders in our program. We use the Faith Inkubators curriculum for our lessons. We also just confirmed 12, 9th graders, on Reformation Sunday (10/25/20).
- →Vacation Bible School (VBS) was held June 15th-June 18th, 2020 for our 3 5 year olds. We partnered with Barneveld Lutheran this summer. Pastor John and Pastor Jim shared creative stories. The children heard recorded songs and worked on crafts together. We had 9 little ones. It wasn't the same as being in person, but many people told me how much their children loved it.
- →Day Camp was held the same week as VBS. Sugar Creek Bible Camp created their Day Camp 2 Go videos, to share worship, Bible study, craft, skits, and favorite songs with the children. Videos were shared with families. This program is for 1st through 5th grade. 18 children had a fun, yet different Day Camp week.
- →Local Mission Week 18 Youth in High School and Middle School participated in our GIVE, LOVE, SERVE week at ELC. Opportunities to volunteer were: chalk drawings, painting cool pictures on rocks, offering our assistance with Neighbors Helping Neighbors, assembling a Madison Reading Project activity, outdoor planting at Stewart Park and helping clean up trash on the bike path.
- →Youthworks Trip Leech Lake : Youthworks did cancel our trip in 2020. If things change with COVID, we could sign up for a last-minute trip in 2021.
- →Thank you Many thanks to everyone who helped support our fundraising efforts throughout the year. The experiences that were shared are so meaningful in their faith walk.
- →FUSE (<u>Faith unleashed</u>. <u>Supporting Everyone</u>) Youth, who are 9th 12th graders are welcome to join our high school group on Mondays. This group comes together to create relationships, show kindness to others, challenge each other in exciting games, time to hang out, and learn about what it means to share our faith with everyone. We have about 10-15 youth who participate.



- →ELC Faith Connection- This Facebook group page is designed to include our congregation and our Mt Horeb Community, of all generations. Our focus is to provide fun, spiritual ways to stay engaged in their faith and with each other, beyond our church walls.
- →Youth Gathering 2022 The Youth Gathering has been moved to July 24 28, 2022 in Minneapolis, MN. Theme is the same: "Boundless, God Beyond Measure". They will keep the Gathering in 2024 as well. Registration will begin fall of 2021. 8th - 12th graders in fall of 2021 may attend. Something to look forward to.

Thank you to everyone who offers their gifts in various ways to help our children and youth to grow in their faith. We are called to serve and love others as Christ loves us.





Report of Pastoral Intern Tamara Siburg

"The Lord is my shepherd; I shall not be in want. The Lord makes me lie down in green pastures and leads me beside still waters. You restore my soul, O Lord, and guide me along right pathways for your name's sake. Though I walk through the valley of the shadow of death, I will fear no evil; for you are with me; your rod and your staff, they comfort me. You prepare a table before me in the presence of my enemies; you anoint my head with oil, and my cup is running over. Surely goodness and mercy shall follow me all the days of my life, and I will dwell in the house of the Lord forever." Psalm 23

Psalm 23 has been a constant thread throughout my life, especially during this time of global pandemic with the need to 'do church' differently. When I affirmed my baptism on my confirmation day, my faith statement was focused around these words of Psalm 23. I spoke of the adversities and challenges that I had experienced in those first 14 years of my life. Little did I know that there would be so many more difficult and emotional challenges that arise throughout my life. Each time I find myself coming back to Psalm 23. At 14, I could never have imagined what this passage would continue to mean to me today fifteen years later.

Today we look around the world and see that all we once knew has drastically changed. Even looking around our community here at ELC, things are different. I have had the joy of being your pastoral intern these past three months. As I continue to get to know you all in various safe manners, we lament together about how different this year is. How it would be so great to be able to gather in person together, how I am getting a very unusual experience on my internship year. At points it feels like walking through a "valley of the shadow of death." Change can bring about death of the 'usual' or the 'old ways,' change can be scary. As we embrace different ways of being church together while distanced, I am encouraged that this is one of the many ways in which God continues to anoint us with oil and overflow our cup as a congregation being a part of God's mission within our community. God is our shepherd, leading us along green pastures and calm waters, restoring our souls and leading us along right pathways.

I truly am excited for what the next nine months will bring as I continue to learn and grow into the pastor that God is calling me to be. I would like to reiterate a deep and heartfelt thank you for being a part of the internship program again this year, for welcoming me with open arms into this community, and for allowing me to learn with you as we imagine together what church and the ministry of ELC can be in such a strange time. Even though this is an unusual year to be an intern, it is still a deeply valuable experience that will continue to inform possible future ministries of the church well into the future knowing that God is leading us through all the difficulties of change and will continue to guide us and be our comforter.

The Committee met on November 19, 2019 and acted on the following items.

- Distribution of interest earned from the Restricted Fund which was paid out on October 15, 2019. Interest earned was \$\$1,759.66. As noted in the England estate, the \$87,955.85 must remain in the Restricted Fund but that the interest should be paid out for benevolent purposes. The following organizations were approved for the following disbursements.
 - \$300 to Agape Preschool
 - \$300 to the Giving Tree of Mt Horeb
 - \$300 to the Mt Horeb Senior Center
 - \$300 to the Mt Horeb Clothes Closet
 - \$400 to the Mt Horeb School District weekend backpack program
 - \$300 to Lutheran Campus Ministry from the Halverson Estate

The Restricted Fund CD has recently renewed and \$1,770.10 interest has been put in the checkbook in anticipation of disbursement. It is planned to be done at the next Endowment Committee meeting sometime in December 2020.

- Deliver goodies and cards crafted by the ELC Sunday School children to our shut-ins at Christmas and Easter. Our ministry was not able to deliver to our homebound ELC members, but we were able to send cards to many members.
- Place Christmas and Easter ads in the Mount Horeb Mail.
- Support Steeple Friends, a ministry team that holds bi-monthly meetings for the residents of the Ingle Living Communities. Due to Covid-19, we were unable to provide services to the residents of the Ingle Living Community.
- Provide Lenten meals following the Wednesday morning Lenten services. Numerous ELC members volunteer their time and baked goods to help make these luncheons a success. We provided two Lenten meals before our pandemic started.
- Encourage ELC leaders to submit articles to the Mount Horeb Mail on various activities; Inreach/Outreach maintains a scrapbook of the same.
- Co-ordinate Sunday morning greeters.
- Maintain/replace pew pad covers, as needed.
- Distribute free water at the Art Fair; R.N.'s provide free blood pressure screening. There was no Art Fair this year.

This year, a group of ELC members have implemented an outreach program for active military and veterans. The group includes Polly Field, Gary Hamburg, Margie Kahl, Holly Thompson, Pastor John, and Dave Baumgartner. Attached is a list of people to be included in our Mission:

- 1. All active military individuals.
 - a. Members of our congregation.
 - b. Someone in the active military(i.e.grandchild,child) who has a family member at ELC.
 - c. ELC members entering the military.
- 2. Members of ELC who were veterans and no longer serve in the military.
- 3. EIC members entering the military.

We had a special church service for one of our members entering the service, honored our active military and veterans in May for Memorial Day and in November for Veterans Day. We organized donations made by our congregation and mailed care packages to our active military.

Property Ministry

In spite of the pandemic, property issues continued to be addressed and resolved. To start, a huge THANK YOU to Betty Drape and Linda Schroeder for their attention to the weeds around the outside of the narthex. And to Rita and Norm Hefty who I've seen praying on their knees at the weeds around the perimeter of the church. They've worked tirelessly, keeping our corner of Mt. Horeb looking fantastic. Whatever would our congregation do without the efforts of our volunteers?

Highlights from 2019-2020 (Because our church year starts in November)

November -

- Huge snow storm with removal and leaking issues.
- Begin work on revised building use agreement.

December -

- Dishwasher problems with the rinse dispenser. Asked Conrad Richer to investigate maintenance issues over the past years and recommend course of action. Possible replacement? Determined the dishwasher is good for the foreseeable future. Replacement not needed now.
- Started looking a potential project to install LED lights and large fans in the sanctuary. Ken Berg donating his time and expertise to develop options and costs.

January -

- Mt. Horeb fire department requested a secure spot for entry to the property if needed. A "Knoxbox" was installed at the main entrance.
- Received a bid from Boley Tree and Landscape for pruning the trees around the property. Council approved the bid. Pruning scheduled for March during Agape school break.
- Dealt with some snow removal issues between Duluth and Anderson. Satisfactorily resolved.
- A tripping accident on the Main Street sidewalk was referred to the Village Office. Contact made to the injured party to work with the Village on restitution. No further action required. (Later saw that the Village smoothed out the hazard.)

February -

- Council approved the redesign of the Facility Use Request document. All current users will be required to submit a new request so it's on file for the future.
- Attended the Dane County "Active Shooter Training" seminar that was held in Fellowship Hall. Made a list of the suggestions for ELC. (More on this later).
- Met with Ken Berg to plan the presentation to the congregation for the "Lights and Fans" project for the sanctuary. April 5 was selected as the date for the congregation meeting to hopefully approve the first phase of the project.

March –

- Stock market issues put the "Lights and Fans" project on hold for now.
- In response to the suggestions from the Active Shooter Training, Kathy and I met with MHTC to discuss options for a more sophisticated phone system. Also met with FDMH and MHPD to review suggestions for identifying the outside doors and how to minimize problems should such an incident occur.
- March 16 virus issues picking up. *Church closed*.
- March 24 Boley crew of 4 pruned all the trees on the property and removed an unwanted tree on the terrace at the addition.
- Contracted with Anderson Landscaping to do the summer mowing.

April -

- Met again with Boley to assess the trees on the south side of the angled parking and the tree at the west side of the Agape playground. One tree is diseased and will need to be removed. The two maples will need pruning. Will be scheduled in 2021. The tree between the playground and the Botham property is dead. Contacted Sarah Botham. Issue of removal is undecided at this time.
- More leaks window in Agape foyer. Fixed. Leak in the Narthex at the pillar next to the nursery. Also notified of a leak in the choir room's west wall. The leaks were fixed by Jamey Schmitz. Because the roof leaks (choir room) are caused by falling stones from the chimney, he suggested acquiring cow mats to be put around the perimeter which will eliminate the punctures from them. Ordered the mats. John and Vicky Rosenbaum offered assistance to pick them up in Verona. Delivered to the Co-op where Jamey arranged to have them taken to the church using a lift.
- Issues with the front doors not closing correctly. Resolved then, but recurred during the summer.
- Installed an address number (315) at the front door, along with door numbers to comply with the recommendations from the FDMH and MHPD. There are 7 outside doors the numbers are on the inside and outside.
- Submitted a bid for repairs from the roof leaks in the narthex and choir room. Awarded to Premier Building.

June –

- Repairs on the inside leaks completed.
- All cow mats installed on the roof.

July -Pretty quiet - ongoing issues with the front doors.

August -

- Asked to dispose of the sheet metal pieces left over from the shack. Received permission from the Village to use their disposal site. John and Vicki Rosenbaum again stepped up to help. All done!
- Noticed leaks from the eaves around several areas of the outside. Submitted two bids for patching and review of the entire structure. One declined. Bid due in September.

September -

- Door issue at the AGAPE handicapped door not closing. AGAPE classroom window shattered. Door fixed and window replacement ordered.
- Roof: Leaking eave problems: Met with representative from Capital Sheet Metal (on the roof) to review all areas of the roof. Because of the condition of the eaves, recommending replacement. Bid response due in October. This will be an agenda item for the Annual Meeting.
- Several other areas were identified as problems that were assigned to the persons doing the stone work and the roof repairs. One area is the stone chimney needs repair work that will be bid out.

What's next? Planning for 2020-2021-2022

- Additional maple tree pruning and removal of the diseased fir tree spring 2021.
- Eave troughs repair and/or replacement if bid approved. Potentially done spring/summer 2021.
- LED lights and ceiling fans in sanctuary can we restart this in 2021?
- Interior painting (especially Chapel)
- Re-shingle the roof target for 2022

Technology

It has been six years since I have started working with the Technology Ministry and this also makes the Technology Ministry six years old as well. Looking back, it is amazing how we have progressed over the six years and the feats that we have accomplished during that time. There were two focus areas that I felt special passion to focus on during that period.

- The first focus area was video streaming to other parts of the church. I was motivated for this initiative during one of the large funerals that we had at ELC. I didn't want the sanctuary capacity to be a limiting factor on a major gathering like this when I knew that technology could help play a part. Since then we have added large screen video capability to both the chapel and Fellowship hall and both now have real-time streaming capability from the sanctuary.
- The second area of focus is the security camera technology. During my time on council, I had heard stories of a few thefts at ELC of some church items and personal items. This really bothered me, and I also thought technology could assist. ELC now has an upgraded video surveillance system and has cameras at all of its entrances. I realize that video surveillance isn't our mission, but it made me feel better knowing that people can feel safe at ELC, especially when age or time of day is a factor. ELC was also to help the Mount Horeb Police Department when they were looking for video footage during one of their investigations. I felt honored to know that at some level ELC was able to assist. There are several other initiatives, like network and computer upgrades, but the streaming and cameras are what I am most proud of.

Since the onset of the pandemic, the focus of the technology ministry needed to turn from the improvements to the physical ELC building to trying to continue the ministry without the physical person interaction. Andy and I halted our weekly ELC improvements and turned the focus to recording and video streaming on the internet. Andy has been working tirelessly on recording and editing each sermon and uploading it to the internet for video and audio streaming. I have been creating Audio CDs of service for those that without the luxury of computer and internet to their home.

The technology ministry is comprised of three primary areas of focus, the sanctuary, social media and computers + networking.

I) The Sanctuary: This involves working with the audio-visual equipment in the sanctuary to enhance the worship services that take place in the sanctuary.

Sanctuary activity: The team continues to present slides, video presentations and weekly announcements on the two computer screens in the sanctuary. Each year we continue to gain more competency with all of the growing AV equipment and have also been able to have minimal outages.

Another activity of the technology ministry is to regularly upload audio recordings of the sermons to the ELC website for those unable to make the live service. To complement the audio feed, we

also now regularly stream live video of the sermons to the ELC Facebook page. The video is available for viewing at any time during or after the actual sermon. The team recognizes the importance of these two services due to all of the members that are unable to attend the service inperson due to health-related and other issues. We have made the Facebook streaming a routine and repeatable process that is now part of our regular Sunday services.

What's next? Possible sanctuary improvements include:

- 1. Prepare for replacement of the aging Sanctuary Laptop.
- 2. Upgrade the video camera.

- 3. Improve the audio capture of the choir area.
 - Social Media: The social media includes
 - The ELC webpage
 - Social Media Websites (Facebook, Twitter, Snapchat)

Social Media activity: There are many opportunities to enhance our ministry using one of the many social media outlets available to us. We recognize the exposure and value that social media provides. We continue to look for ways that we can use the resources available to use to touch the lives of more people.

Pastor John regularly posts upcoming events, pictures, video, and notes regarding upcoming services to the Facebook page. In addition, several other ministries also have the ability to post to the ELC Facebook page as well.

What's next? Possible areas of improvement include:

- 1. Outreach to our home or nursing home bound members, letting them know how they can access the sermons and information. \As technology improves and new capabilities continue to become available, we'd like to make use of the opportunity.
- 2. Find other media options for sermon live-stream in addition to Facebook.

This is an area where there is so much potential, that we likely underutilize. We are seeking an individual to become part of the team who would be interested in leading this aspect of our technology team.

- III) Computers + Networking
 - Desktop / Laptop hardware and software maintenance and upgrades
 - Printers / Scanners maintenance and upgrades
 - Network maintenance and upgrades

Computers and Networking: Similar to previous years, the team has spent many hours stringing CAT6 internet wire throughout the church to expand the ELC network. In addition to all of the hardwired network upgrades, we have also updated the ELC wireless network in several locations.

What's next? The team would like to continue to build on the ELC technologies, network and presentation capabilities. Some potential improvements include:

- 1. Provide over the air TV reception to Saint Olaf.
- 2. Look for new TV monitors throughout the church. With our recent network improvements, we are now able to stream video to other locations in the church. We have think there may be value to stream to other parts of the church that we haven't been able to.

The team is made up of the following members. Andy Mullendore, John Coffin and Bruce Meister. The team meets regularly and invites you to join the team. As you can see, we have several areas that may fit your interest. Please watch the church calendar for meeting dates and times.
