2024-2025 School year

Agape Christian Preschool (ACP) is a non-denominational, non-profit outreach ministry of the Evangelical Lutheran Church of Mount Horeb. It is the mission of ACP to provide a high-quality, early childhood education to children ages 3 through 5 (pre-kindergarten) as well as collaborating with the MHASD Community 4K program.

The ACP program has been ongoing for the past 34 years. The 2024-2025 school year has started out well, in our eleventh year of separate 3K and 4K classes. The current enrollment in the 3K class is lower this year, but we are working to fill the openings as the school year progresses. The 4K program also has a lower enrollment number, like the other three MHASD community 4K sites. Toddler Time, held on Friday mornings for $1 \frac{1}{2}$ to 2-year-old children & care givers, has started off with a great turnout this school year. We are grateful to be able to offer this outreach program to our community. We have a wonderful group of children and staff learning and working together. The preschool classes are taught by our remarkable teaching staff – Cathy Fountas, Megan Kelly, Jenelle Ollendick, Wendy Rasmussen, Katy Seibel, and Anita Symons.

A new security camera system with costs estimated at over \$5,000 has been ordered and received. We are planning installation to happen later this year or in early 2025. Once installed, the main doors to the preschool, chapel and front entry will have exterior cameras and communication abilities for both Nancy and I to provide secure building entry. We have applied for a grant from the Mt Horeb Community Foundation to help with the cost of this project and are awaiting approval.

The board of directors is continually brainstorming ideas for effective and profitable fundraisers. In addition to the ever-popular annual butter braid sale taking place in the spring of 2025, we will have Kwik Trip car wash cards for sale this fall. Cards will be sold for \$36.00 for five Ultimate car washes. Great savings and great for gift giving! We will host a Brats In The Lot at Miller's Supermarket this coming spring and monthly Scholastic book orders will be offered multiple times throughout the school year to all preschool families. These fundraisers are incorporated to aid in the financial support of curriculum, scholarships, and other unforeseen expenses to keep enrollment fees at a minimal expense for our families. The current budget for the 2024-2025 school year is included.

It is a pleasure to recognize our current board members: Brittany Kahl (Treasurer), Megan Kelly, Kim Lins, Leah Roethle, Vicky Rosenbaum (Council Liaison), Becky Strube, Elizabeth Thronson (Secretary), and Anne Woolard (Chairperson).

Thank you to all current and former board members for giving their time and dedication to the ACP ministry.

Property Ministry

I'LL START THIS REPORT WITH AMAZING ACCOMPLISHMENTS FROM THE PAST YEAR!

The month of June:

Last year's Annual Meeting approved budget money for replacement of the sanctuary ceiling and front panel lights with LED's, and painting the pillars and surface areas. Also, additional dollars were allocated to replace the corroding sidewalks into the narthex and chapel.

June of this year the lights, painting and sidewalks were completed.

Unplanned, but accomplished, were new pendant lights in honor of Dawn Kellesvig from her family and friends. Such an amazing transformation!

While the 40' lift was in the sanctuary all pillars and surface areas were painted.

A hard-working group of volunteers cleaned the sanctuary – pews, altar, communion rail, hymnal racks. It looked and smelled wonderful!

The disintegrating entry sidewalks into the Narthex and Chapel entries were torn out and replaced. Another beautiful look for our property.

OTHER ACCOMPLISHMENTS:

The Chapel entry had new led lights installed to resolve the stairway hazard during evening and night services.

And, thanks to the tireless work of Funeral Helpers, the failing kitchen commercial refrigerator was replaced. It was totally paid for from the funds received from hosting funeral luncheons.

Squirrel in the building in August! Who would have thought it could have made so much mess! She and her three babies were finally trapped and taken out Aug 25. Continued to find droppings all over the building. Last of the stuff were finally cleaned up in time for the big event on August 31, Micah Sieg's Ordination!

God's Work Our Hands, meant to be a community *Outreach* day, culminated in an *Inreach* for ELC. Sunday, September 8, saw adult volunteers clean the Chapel and the lower entry to the Chapel. Eight youngsters collected all the Pew Pads from the chapel and sanctuary and replaced the broken ones, filled missing pads and sharpened all the pencils! The kids had a great time and did a great job!

Complete rewiring of the sanctuary ceiling light switches was accomplished by Oimoen Electric. This eliminated numerous "switching" from the electrical panel, resulting in **one switch** to control them. A serious note regarding the ceiling lights: the LED lights that were installed are **NOT DIMMABLE**. Therefore, the 4'x4'x4' box in the electrical closet was removed in conjunction with the rewiring.

ONGOING ISSUES:

Continual roof leaks from the flat roof over the choir room and narthex were investigated. Determination made that the rubberized roof material was brittle and cracked. Our roofer, Jamey Schmitz, was diligent in coming to find the leaks and patch them. A fund-raising program was started with the hope to have the replacement done next year.

Property Ministry

The door into the chapel from Front Street continues to be problematic. It does not latch unless forced, and the key lock is loose. This is a security issue since the building is always locked. John Theobald is working on permanent solutions.

Storms continue to leak significant water into the basement. Estimates were received from two contractors. Council has selected one to include in the budget proposal for hopeful approval at the annual meeting. The solution is to dig outside on the east side and waterproof the block wall. The downside is that the landscaping done two years ago will need to be replaced.

More issues with leaking from the significant spring rainstorms. Serious cracks in the stone and stucco have been discovered. Travis Stram has been working on them as his time allows, and anticipate by the time of this meeting all will have been resolved.

The AC "mini-split" unit in the fellowship hall's south east corner has failed. Replacement will be scheduled for next year if there are funds to purchase and install. In the interim, all "mini-splits" in both buildings need to be cleaned and disinfected.

A year ago, a split in the upper wood in the Chapel altar was discovered. In addition, during the cleaning of the Chapel, we were unable to dust/wash the ornate decorations because the entire upper structure could be fragile.

Adam Stapleman inspected the altar, and, outside of the split, deemed it in good condition for its age. Decision made to not attempt any type of repair.

He did take one of the "throne" chairs to glue the broken pieces.

Suggestions for cleaning were to use only a light cloth or "Swiffer" to lightly dust the ornate pieces. This will require a 20' step ladder and someone not afraid of heights! Volunteers needed!

We're in the process of a fundraiser for funds for the roof repair. A beautiful queen-size quilt made by past member Linda Topper was donated by her husband John. Raffle tickets of \$10 each are being sold until November 17th. An announcement of progress will be made at the Annual Meeting.

LOOKING AHEAD:

Of course, the "big events" of roof repair and waterproofing the basement will take center stage. Other items on the to-do list for continuing enhancement of our property and building are the clean out and painting of the nursery; cleaning out of the library; painting the walls in the narthex and hallways. Volunteers will be solicited for these activities! These were on the report last year – didn't get accomplished.

Our efforts to pair with the Christ the Solid Rock Baptist Church to learn of their welcoming efforts were put on hold as they work to find a new building after their partnership dissolved.

The RIC and Pride Flags continue to be a challenge to display due to strong winds in front of the Church that break the flag poles. We are working to find stronger poles and/or better display options.

As always, we encourage people to volunteer to serve on our committee. We are constantly seeking new ways to live and encourage the words of our Welcome Statement, and your input would be greatly appreciated.

Technology Ministry

The primary focus of the technology ministry over the past year was as follows:

Sunday Services: Operation of sound equipment and projection screens. This includes assisting in developing the announcement videos and slides on a weekly basis. We continue to live stream services via Facebook Live and YouTube. In 2024, the average number of views was 18.6 per weekend, up from 16.4 in 2023. We also streamed using the Phonelivestreaming.com platform, a paid service until October, but have discontinued this due to the expense and lack of use.

Maintenance of Computer and Associated Office Equipment: Throughout the year we assisted with troubling shooting network issues and replacing the last of the access points that have reached the end of life and were no longer supported. We also implemented the use of constant contact to provide regular communication between Pastor John and Brenda and the congregation. This limits the potential for their e-mail addresses from being identified as spam, due to sending large amounts of e-mail.

In the coming year our focus will be on the following areas:

- 1. Continue to improve our ability to livestream services.
- 2. Complete video doorbell installation at the main entrances and installation of a security camera to monitor the Agape playground
- 4. Grow the technology team
- 5. Evaluate and improve our workflow for preparation of slides and announcements.

The technology team currently consists of Andy Mullendore, Bruce Meister, John Coffin, and Ryan Bredeson. We would love to add more people to the team and no technical background is required. Please contact Andy or Bruce (or leave a note at the church office) if you would like to assist in any way.

REPORTS OF THE TREASURER

Treasurer's 2024 Annual Report and Proposed 2025 Budget

Thank you to everyone whose gifts, monetary and otherwise, help us worship and serve God here at ELC. We are all stewards of a great many blessings, and it's gratifying to see how many people use those gifts for the glory of God.

Many of you have noticed that our general fund balances have been very low over the last several years. That continues to be the case. To a first approximation, the reason is that our resources have not been sufficient to fund the internship program on a sustainable basis.

That's okay! It was a leap of faith. We've all benefited from our participation in the program over the past several years; from getting to know Jason, Tamara, Joseph, Jerome, and Zach; and from helping raise up the next generation of ministers for the wider church. It was worth the financial risk. But over the medium term, our expenses need to more closely match our resources.

At the end of last month, we had a \$2,009 deficit in the general fund, down \$11,495 from the start of the year. Expenses were front-loaded this year because of the internship program, and we should make up some of that gap if December giving follows historical trends. We've also allocated money in the 2025 budget to help restore the designated-fund reserves we've dipped into to make ends meet.

This year the big project is a new roof. We've received donations and commitments of just over \$47,000. That leaves us slightly over 60% of the way towards the \$75,000 we'd like to raise. If the congregation approves the expense at the annual meeting, we're looking at getting the roof installed next summer. These large capital projects are funded from the building capital fund, and not from the general fund.

You can find the proposed general fund budget for 2025 at the end of this report.

In discussing the budget, I always want to emphasize that our budget has relatively low discretionary spending. 66% is spent on personnel (many thanks for the great job they all do!), and 23% is needed to maintain the building. 6% goes to mission work, supporting a number of important organizations, including Lutheran Campus Ministry and Lutheran Social Services, Sugar Creek Bible Camp, and our synod. Everything else, including Lenten meals, Sunday coffee and donuts, music and streaming licenses, continuing education, devotional material, and much more, comes from the remaining 5%.

The other thing to emphasize is that this isn't a top-down budget. The council's starting point is always to ask the many ministry committees what resources they need to accomplish their goals. We try to match our resources with the goals and ideas of members in using those resources. Getting involved with these ministries doesn't require elections or registration. Just show up!

The proposed 2025 budget projects income of \$385,950. That represents a 1.1% increase over the \$381,663 we're projecting for 2024. Note that our bottom-line estimate for 2024 income of \$392,663 includes \$11,000 transferred from the designated funds, which should not be considered true giving.

Most of our 2025 expenses should be similar to this year's. Personnel expenses include a 3% raise for staff, as well as \$15,000 allocated to new part-time custodial and maintenance positions we will be looking to fill. Many thanks to Brian for years of excellent service!

We've also allocated \$7,150 for intern salary. That amount is the current deficit in the internship designated fund. Because we were not able to fund this year's internship program out of our general fund revenue or from the designated internship fund, we were forced to borrow from the unspecified designated fund, which is our church's reserve fund. Our hope is to pay that money back in 2025. (This \$7,150 is separate from the \$11,000 transfer mentioned above.)

Other changes of note include more money for call pastors, higher telecom bills, and ending our support for Lutherdale Bible Camp, concentrating instead on supporting Sugar Creek. We expect inflationary pressures on most facility expenses to ease somewhat.

All told, this pencils out to a small decrease in expenses compared to 2024. If our income and expense projections are accurate, we'll end the year slightly in the black. We feel this is a solid budget that will help us get our feet under us again, after a few years of over-extension.
